**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of October 22, 2015, is made by Bank of America, N.A., as Administrative Agent under the First Lien Credit Agreement (the "Agent"), in favor of Pro Access L.L.C., a New Jersey limited liability company (the "Grantor") as follows:

**WITNESSETH**

WHEREAS, pursuant to the First Lien Security Agreement, dated as of April 2, 2014 (as such agreement may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), and the Trademark Security Agreement, which references the Security Agreement, dated as of April 2, 2014 (as such agreement may be amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), the Grantor granted the Agent a first priority Lien on and security interest in all of its right, title and interest in, to and under the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule A attached hereto;

WHEREAS, the First Lien Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office on April 8, 2014 at Reel/Frame 5255/0520;

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Agent; and

WHEREAS, the Grantor has requested that the Agent release its Liens on and security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, the Agent, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby (i) terminates the Trademark Security Agreement and (ii) terminates, cancels and releases its Liens on and security interest in the Trademark Collateral and any and all right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.


