ARTICLES OF ORGANIZATION  
OF  
QC SUPPLY, LLC

The undersigned, desiring to form a limited liability company for the purposes set forth, under and in conformity with the laws of the State of Nebraska do hereby make this written certificate in duplicate and hereby verify:

ARTICLE I.

Name

The name of the company shall be QC SUPPLY, LLC, hereinafter referred to as "the Company".

ARTICLE II.

Duration

The period of duration of the Company will be perpetual from the date these Articles of Organization are filed with the Secretary of State of the State of Nebraska.

ARTICLE III.

Purpose

The Company is organized to engage in and to do any lawful act concerning any and all lawful business, other than banking or insurance, for which a limited liability company may be organized under the laws of Nebraska.

ARTICLE IV.

Principal Place of Business

ARTICLE V.

Initial Registered Office and  
Initial Registered Agent

The street address of the initial registered office of the Company is 510 Sandy Shores Drive, Schuyler, NE 68661 and the name of the Company's registered agent at such address is Lonnie Kitt.

ARTICLE VI.

Property Contributed

The total amount of cash and a description and agreed value of property other than cash contributed is as follows:

ARTICLE VII.

Additional Contributions

Additional contributions shall made at such times and in such amounts as may unanimously agreed by the Members as provided in the Operating Agreement of the Company.

ARTICLE VIII.

Additional Members

The members of the Company have the right to admit additional members from time to time, upon the affirmative vote of a majority in interest of the current members and upon additional terms and conditions of admission as may determined by the members at the time of admission. Except as provided in the Operating Agreement, the interests of the members in the Company may transferred or assigned.

ARTICLE IX.

Right to Continue Business

In the event of the death, retirement, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, then by the consent of the remaining members consisting of at least a two-thirds (2/3) majority in interest of the Company such members shall have the right to continue the business of the Company at their election and option.

ARTICLE X.

Management

Management of the Company shall vested in a one-percent interest to be retained by Lonnie Kitt and Patti Kitt and shall pass with the one-percent interest when it is transferred. The names and addresses of the members are:


