**TRADEMARK AND DOMAIN NAME ASSIGNMENT**

THIS TRADEMARK AND DOMAIN NAME ASSIGNMENT is effective as of February 4, 2014.

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, and pursuant to the terms and conditions of the Agreement, the Assignor hereby assigns, transfers, conveys and delivers to Assignee and its successors and assigns, all of its right, title and interest throughout the world in, to and under the Trademarks, all goodwill associated therewith or symbolized thereby, all common law rights thereto, all registrations that have been or may be granted thereon, all applications for registration thereof, all records and files relating to said Trademarks and all foreign counterparts thereof, together with the right to sue and recover damages for future or past infringements thereof and to fully and entirely stand in the place of the Assignor in all matters related thereto.

AND, the Assignor hereby assigns the Domain Names and agrees to cooperate fully with Assignee to execute the electronic transfer of the Domain Names from the Assignor's account(s) with the applicable domain name registrars to the Assignee's account(s) with the applicable domain name registrars. The Assignor further agrees to duly execute and deliver or cause to be executed and delivered all other instruments of sale, conveyance, transfer and assignment, and notices, releases, acquittances and other documents and perform such further acts as may be necessary to convey, transfer, assign, deliver to, consolidate, vest and record in Assignee, full ownership of the Domain Names and other rights conveyed herewith, and to perfect Assignee's rights in and to the Domain Names, including, without limitation, providing authorization to the applicable domain name registrars and their respective designees;

AND, the Assignor hereby requests the Director of the United States Patent and Trademark Office (the "**Director**"), as well as his or her non-US counterparts in the non-US jurisdictions which exercise authority over any of the Trademarks to record this Trademark and Domain Name Assignment. The Assignor hereby further requests the Director and his or her

non-US counterparts to issue any and all trademarks resulting from trademarks claiming the benefit of one or more of the Trademarks to Assignee as assignee of the entire interest therein.

At any time prior to one year after the date hereof, and at Assignee's request, the Assignor agrees to execute further documents and instruments and to do such other acts as may be necessary or reasonably requested by Assignee to more effectively vest full title in and to the Trademarks and Domain Names in the Assignee. This Assignment shall be binding upon and shall inure to the benefit of the respective successors and permitted assigns of the Assignor and Assignee.
