RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of October 16, 2015, by CGP MANAGERS, L.L.C., as Agent (the "Agent") to NJOY, INC. ("Grantor"). Reference is hereby made to that certain Notice of Grant of Security Interest in Trademarks between the Grantor and the Agent dated October 2, 2015, recorded in the United States Patent and Trademark Office ("USPTO") on October 5, 2015 at Reel 5637/ Frame 0332 (the "Trademark Security Agreement"). Terms used but not defined in this Release shall have the meanings given thereto in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement, the Agent was granted a security interest in and to the intellectual property, including the trademarks listed on Schedule 1 (the "Trademark Collateral");

WHEREAS, the Grantor has requested that the Agent terminate and release its security interests in and to the Trademark Collateral and execute and deliver evidence of such termination and release for filing in the USPTO; and

WHEREAS, the Agent has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby releases and terminates all security interests and other interests it may have in the Trademark Collateral. Grantor (or its designee) is hereby authorized to file this Release with the USPTO and any other governmental authority.


