RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST dated as of October 6, 2015 (this "Release") is made by Fifth Street Finance Corp., a Delaware corporation, acting in its capacity as administrative agent (in such capacity, the "Administrative Agent") under that certain Security and Pledge Agreement, dated as of October 31, 2013 (as amended, modified, extended or restated from time to time, the "Security Agreement") by and between Opfree Licensing LP, a Texas limited liability ~~company~~ ("Opfree"), the other Obligors party thereto and the Administrative Agent.

Partnership

WHEREAS, pursuant to the Security Agreement, Opfree granted to the Administrative Agent a continuing security interest in all of Opfree's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached Schedule A, and associated goodwill (the "Trademark Collateral");

WHEREAS, pursuant to the Security Agreement, Opfree and the Administrative Agent executed the Notice of Grant of Security Interest in Trademarks, dated as of October 31, 2013, which was recorded in the records of the United States Patent and Trademark Office on October 31, 2013 at reel 5142, frame 0933; and

WHEREAS, Opfree has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.


