## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "*Release*"), dated as of October 22, 2015, is made by KeyBank National Association, as the Administrative Agent (as defined below), in favor of each of NT Network Services, LLC, a Delaware limited liability company, and GTT Communications, Inc., a Delaware corporation (each, a "*Grantor*", and collectively, the "*Grantors*").

A. Reference is made to the Second Amended and Restated Credit Agreement, dated as of August 6, 2014, among the Borrowers (as defined therein), the Lenders party thereto and Webster Bank, N.A., as the administrative agent (as amended by the Amendment Agreement, dated as of April 1, 2015, by and among GTT Communications Inc., the other Borrowers (as defined therein) party thereto, the Lenders party thereto, and KeyBank National Association, as administrative agent (the "*Administrative Agent*") and as otherwise amended, restated supplemented or otherwise modified from time to time, the "*Credit Agreement*"). Capitalized terms not otherwise defined herein shall have the meanings set forth in the Credit Agreement.

B. Reference is made to (i) the Second Amended and Restated Security Agreement, dated as of April 1, 2015, (as amended, restated, supplemented or otherwise modified from time to time, the "*Security Agreement*"), among the Grantors, the other grantors named therein and the Administrative Agent, and (ii) the Amended and Restated Trademark Security Agreement, dated as of April 1, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*"), among the Grantors and the Administrative Agent, pursuant to which, among other things, the Grantors granted a security interest to the Administrative Agent, for the benefit of the Lenders, in, among other things, the Trademark Collateral (as defined in the IP Security Agreement), including, without limitation, each trademark, trademark application and trademark license of the Grantors set forth on Schedule 1 hereto (collectively, the "*Trademarks*").

C. In connection with the termination of the Credit Agreement, the Security Agreement and the IP Security Agreement, the Grantors have informed the Administrative Agent of their desire to obtain the release of all right, title and interest of the Administrative Agent, the Lenders and each other grantee or beneficiary in and to the Trademark Collateral granted under the Security Agreement and the IP Security Agreement.

D. Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Administrative Agent's right, title and interest (including, without limitation, security interests) in and to the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule 1 attached hereto, pursuant to the Security Agreement and the IP Security Agreement, is hereby automatically, immediately and forever terminated, the debt secured thereby having been paid and satisfied in full and any right, title or interest of the Administrative Agent in such Trademarks hereby cease and are void.

E. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby at the cost and request of the Grantor. This Release shall be construed in accordance with and governed by the laws of the State of New York.
