TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Agreement") is entered into as of the last date of signature below by and between **Stephen Turrini** ("Assignor"), an individual residing in California, and **Sazerac Brands, LLC** ("Assignee"), a Delaware limited liability company (collectively, the "Parties").
