WHEREAS, International Vapor Group, Inc. a Delaware corporation previously with a principal place of business at 15050 NW 79 Court, Suite 101A, Miami Lakes, Florida, and now located at 14300 Commerce Way, Miami Lakes, FL 33016, hereinafter referred to as Assignor, is the owner of the mark "VAPOR ZONE", registered with the United States Patent and Trademark Office under Registration Nos. 4,555,202 and 4,499,590 for cartridges sold filled with propylene glycol for electronic cigarettes; cartridges sold filled with vegetable glycerin for electronic cigarettes; cartridges sold filled with chemical flavorings in liquid form for electronic cigarettes; chemical flavorings in liquid form used to refill electronic cigarette cartridges; electronic cigarette liquid (e-liquid) comprised of flavorings in liquid form used to refill electronic cigarette cartridges; electronic cigarettes; electronic cigarette refill cartridges sold empty; electronic cigarette atomizers; electronic cigarette filters; cigarettes containing tobacco substitutes not for medical purposes; electronic cigarette cartridges sold empty; electronic cigarette for consuming herbal appetite suppressants, caffeine, nutritional and dietary supplements and vitamins; nicotine free electronic cigarettes; electronic cigarette kits, each consisting of electronic cigarette cartridges sold empty, a battery, a battery charger that can be plugged into a wall, and an atomizer; carrying cases specifically designed to carry electronic cigarettes; wholesale distributorships featuring electronic cigarettes, electronic cigarette cartridges, electronic cigarette atomizers, electronic cigarette filters, electronic cigarette refill liquids, cigarettes containing tobacco substitutes not for medical purposes, electronic cigarette for consuming herbal appetite suppressants, caffeine, nutritional and dietary supplements and vitamins, and nicotine free electronic cigarettes; retail store services and on-line retail store services featuring electronic cigarettes, electronic cigarette cartridges, electronic cigarette atomizers, electronic cigarette filters, electronic cigarette refill liquids, cigarettes containing tobacco substitutes not for medical purposes, electronic cigarette for consuming herbal appetite suppressants, caffeine, nutritional and dietary supplements and vitamins, and nicotine free electronic cigarettes;

WHEREAS, CompuZone, Inc., doing business as VapingZone, a South Carolina corporation with a principal place of business at 378 Columbiana Drive, Suite 4, Columbia, SC 29212, hereinafter referred to as Assignee, is desirous of acquiring said mark and registrations;
