## TERMINATION OF PATENT AND TRADEMARK SECURITY AGREEMENT

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of even date herewith, the Secured Party hereby releases and reassigns without warranty or recourse to the Grantor and its successor Bandsintown, LLC the interest in the Patent and Trademark listed on Exhibit A and Exhibit B attached hereto in which the Secured Party was granted a security interest under the Agreement.

The Secured Party acknowledges that it is the purpose of this document to memorialize the aforementioned release of its security interest in the Patent listed in Exhibit A and in the Trademark listed in Exhibit B attached hereto in a form suitable for recordation in the United States Patent and Trademark Office and hereby consents to the recording of this document in the United States Patent and Trademark Office.
