RELEASE OF TRADEMARK SECURITY INTEREST

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, MEDLEY SBIC, LP, a Delaware limited partnership (the “Administrative Agent”), as administrative agent pursuant to that certain Intellectual Property Security Agreement dated as of September 19, 2014, by and among Mirror Acquisition, LLC (the “Grantor”) and Administrative Agent (as the same may have been amended, modified, restated, or supplemented from time to time, the “IP Security Agreement”) granted in conjunction with that certain Security Agreement, dated as of November 27, 2013, with and in favor of Administrative Agent for the ratable benefit of the Lenders (as defined therein), does hereby, on behalf of itself and the Lenders, unconditionally and expressly release, terminate and forever discharge and extinguish any and all of its right, title and interest in and to any and all liens and security interests it may have under all intellectual property collateral identified in the IP Security Agreement, including the trademark registrations, applications, and licenses listed on Exhibit A attached hereto (the “Released Collateral”), arising from the IP Security Agreement, which was recorded in the United States Patent and Trademark Office on or about September 22, 2014, against the United States trademark registrations, applications, and licenses listed on Exhibit A at Reel/Frame Numbers 5366/0911. The Administrative Agent hereby releases, retransfers and reassigns to the Grantor the security interest and all of the Administrative Agent’s right, title and interest in, to and under the Released Collateral. The Administrative Agent will execute and deliver, at the request and cost of Grantor, such further instruments, documents and release forms as Grantor may reasonably request to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.

The Administrative Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release of Trademark Security Interest.


