CONFIRMATORY TRADEMARK ASSIGNMENT

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to record Assignee as the owner of any and all of Assignor's rights in the Trademarks.

This Assignment shall be governed by and construed in accordance with the laws of the State of New York, without giving effect to any choice of law or conflict of law provision or rule that would cause the application of the laws of any jurisdiction other than the State of New York. Jurisdiction of any dispute shall be the United States District Court for the Southern District of New York. Both Assignor and Assignee irrevocably agree that such suits, actions or proceedings may only be commenced or prosecuted in such court, and each irrevocably waives any claim that any such court constitutes an inconvenient forum for the prosecution of such suit, action or proceeding. Both of the parties irrevocably agree not to seek the transfer of any such suit, action or proceeding to any court located outside of the United States District Court for the Southern District of New York.

This Assignment may be executed in counterparts, including by facsimile or PDF, each of which will be deemed an original, but all of which together constitute one and the same original.
