**TRADEMARK ASSIGNMENT**

This Agreement is by and between Hood Rivers Distillers, Inc., a corporation organized and existing under the laws of the State of Oregon, and having its principal place of business at 660 Riverside Drive, Hood River, Oregon 97031, United States of America (hereinafter SELLER) and Brokers Gin Limited, a company incorporated and registered in England and Wales with company registration number 3570094, having its registered office at Dial House, Govett Avenue, Shepperton, Surrey TW17 8AG, United Kingdom (hereinafter BUYER).

The parties confirm and agree as follows:

1. Seller is the owner of record of US Trademark Registration 0925621 for the mark BROKer's for whiskey and of US Trademark Registration 2703781 for the mark BROKER'S for distilled spirits. These two registrations are hereinafter called The Registrations. In this assignment, the term Marks means BROKER'S in design and word form for distilled spirits and thus includes the marks of The Registrations. Seller has been selling BROKer's whiskey (also known synonymously as whisky) and gin in the United States.

2. Subject to a Trademark Purchase Agreement between Buyer and Seller and an Exclusive License from BUYER to SELLER to use the Marks for whiskey, SELLER, hereby sells, assigns, transfers and sets over to BUYER, its successors, legal representatives and assigns, the entire right, title and interest of SELLER in and to The Registrations, and to the Marks, together with any related good will of SELLER symbolized by the Marks, and all claims for infringement of SELLER's rights in the Marks, if any, which may have arisen prior to the date of this Assignment. Seller hereby also sells, assigns, transfers and sets over to Buyer, its successors, legal representatives and assigns, the entire right, title and interest of Seller in and to BROKER'S as a trade name for distilled spirits.

3. BUYER hereby accepts this sale, assignment, transfer and set over of SELLER'S rights.

4. BUYER and SELLER each confirm that its respective signatory below is authorized to sign this Agreement.
