RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of November 2, 2015, by JPMorgan Chase Bank, N.A., as Administrative Agent for the Lenders from time to time parties to the First Lien Credit Agreement (as defined in the Trademark Security Agreement) (the "Assignor") in favor of Granite Broadcasting Corporation and KBJR, Inc. (collectively, the "Assignees").

WHEREAS, the Assignees and the Assignor entered into that certain Grant of Security Interest in Trademarks, dated as of May 23, 2012 (the "Trademark Security Agreement"), pursuant to which Assignees pledged and granted to Assignor a security continuing interest in, and a right of setoff against, all of the Assignees' right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement) (including the trademarks set forth on Schedule A);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 29, 2012 at Reel 4812, Frame 0290;

WHEREAS, the Assignor has agreed to release all of its liens on the Collateral, and to convey any and all of its rights in the Collateral to the Assignees identified in Schedule A for the respective trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby releases all of its rights in and to the Collateral and conveys to the Assignees all of the Assignor's right, title and interest in and to the Collateral, in each case, without warranty or representation of any kind. This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
