**SECOND AMENDMENT TO
AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **SECOND AMENDMENT TO AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT**, dated as of October 30, 2015 (this "Amendment"), amends the Amended and Restated Intellectual Property Security Agreement, dated as of June 17, 2004, as amended (the "IP Security Agreement"), by and between **NORPAC FOODS, INC.**, an Oregon cooperative corporation ("Debtor"), and **COBANK, ACB**, as collateral agent ("Agent") for itself and the Lenders party to the Third Amended and Restated Loan and Security Agreement dated as of the date hereof and described below, as the same may be amended and/or restated from time to time ("Third Restated Loan Agreement").

WITNESSETH

WHEREAS, the parties executed the First Amendment to Amended and Restated Intellectual Property Security Agreement, dated as of December 28, 2012 ("First Amendment"), in order to replace the trademarks schedule and update all references made therein to reflect the Second Amended and Restated Loan and Security Agreement, dated as of October 8, 2009, as amended and acknowledged, by and between Agent, Debtor, Hermiston Foods, LLC, an Oregon limited liability company ("Hermiston"), and Quincy Foods, LLC, a Washington limited liability company ("Quincy");

WHEREAS, concurrently herewith, Agent, Debtor, Hermiston, Quincy, and the Lenders party thereto are entering into the Third Restated Loan Agreement, and, in connection therewith, desire to amend the IP Security Agreement to incorporate a new trademark schedule and update all references made therein to reflect the Third Restated Loan Agreement; and

WHEREAS, Agent has agreed to amend the IP Security Agreement on the terms and conditions set forth in this Amendment.

NOW, THEREFORE, the parties hereto hereby agree as follows:

1. Intent of Parties. The intent of this Amendment is to cause the relative priorities and rights of the parties under the IP Security Agreement to continue in effect after giving effect to the Third Restated Loan Agreement.

2. Defined Terms. Except as otherwise provided in this Amendment, terms defined in the IP Security Agreement and used herein shall have the meanings given to them in the IP Security Agreement and references to sections shall mean to sections in the IP Security Agreement.

3. Amendments.

(a) Schedule A of the IP Security Agreement is hereby replaced with Schedule A attached hereto.

(b) The IP Security Agreement is hereby amended by (i) substituting a reference to the "Third Restated Loan Agreement" as herein defined in place of each reference to the "Loan and Security Agreement" as defined in the First Amendment (or other defined term for the Loan

and Security Agreement, if any); (ii) substituting for all references to specific sections of the Loan and Security Agreement to the corresponding sections of the Third Restated Loan Agreement; and (iii) substituting for the definition of each capitalized term defined by reference to the Loan and Security Agreement the definition of such capitalized term set forth in the Third Restated Loan Agreement.

4. Counterparts; Telefacsimile Execution. This Amendment may be executed in any number of counterparts and by different parties on separate counterparts, each of which, when executed and delivered, shall be deemed to be an original, and all of which, when taken together, shall constitute but one and the same Amendment. Delivery of an executed counterpart

of this Amendment by telefacsimile shall be equally as effective as delivery of a manually executed counterpart of this Amendment. Any party delivering an executed counterpart of this Amendment by telefacsimile also shall deliver a manually executed counterpart of this Amendment but the failure to deliver a manually executed counterpart shall not affect the validity, enforceability, and binding effect of this Amendment.

5. Section Headings. Headings and numbers have been set forth herein for convenience only. Unless the contrary is compelled by the context, everything contained in each section applies equally to this entire Amendment.

6. Severability of Provisions. Each provision of this Amendment shall be severable from every other provision of this Amendment for the purpose of determining the legal enforceability of any specific provision.


7. Continuing Effect of Other Documents. This Amendment shall not constitute an amendment or waiver of any other provision of the IP Security Agreement not expressly referred to herein and shall not be construed as a waiver or consent to any further or future action on the part of parties hereto that would require a waiver or consent of any of such parties. As amended hereby, the provisions of the IP Security Agreement are and shall remain in full force and effect, and are hereby reaffirmed. All references in the "IP Security Agreement" shall, for the avoidance of doubt, be references to the IP Security Agreement as amended by the First Amendment and this Amendment.

8. CHOICE OF LAW; JURY TRIAL WAIVER. THE VALIDITY OF THIS AMENDMENT, ITS CONSTRUCTION, INTERPRETATION, AND ENFORCEMENT, AND THE RIGHTS OF THE PARTIES HERETO WITH RESPECT TO ALL MATTERS ARISING HEREUNDER OR RELATED HERETO SHALL BE DETERMINED UNDER, GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF COLORADO, WITHOUT GIVING EFFECT TO ITS CONFLICT OF LAWS PRINCIPLES. THE PARTIES AGREE THAT ALL ACTIONS OR PROCEEDINGS ARISING IN CONNECTION WITH THIS AMENDMENT SHALL BE TRIED AND LITIGATED ONLY IN THE STATE AND FEDERAL COURTS LOCATED IN THE COUNTY OF DENVER, STATE OF COLORADO OR, AT THE SOLE OPTION OF AGENT, IN ANY OTHER COURT IN WHICH THE AGENT SHALL INITIATE LEGAL OR EQUITABLE PROCEEDINGS AND WHICH HAS SUBJECT MATTER JURISDICTION OVER THE MATTER IN CONTROVERSY. EACH OF DEBTOR AND AGENT WAIVES, TO THE EXTENT PERMITTED UNDER APPLICABLE LAW, ANY RIGHT EACH MAY HAVE TO ASSERT THE DOCTRINE OF FORUM NON CONVENIENS OR TO OBJECT TO VENUE TO THE EXTENT ANY PROCEEDING IS BROUGHT IN ACCORDANCE WITH THIS SECTION 8. DEBTOR AND AGENT HEREBY WAIVE THEIR RESPECTIVE RIGHTS TO A JURY TRIAL OF ANY CLAIM OR CAUSE OF ACTION BASED UPON OR ARISING OUT OF ANY OF THE LOAN DOCUMENTS OR ANY OF THE TRANSACTIONS CONTEMPLATED THEREIN, INCLUDING CONTRACT CLAIMS, TORT CLAIMS, BREACH OF DUTY CLAIMS, AND ALL OTHER COMMON LAW OR STATUTORY CLAIMS. DEBTOR AND AGENT REPRESENT THAT EACH HAS REVIEWED THIS WAIVER AND EACH KNOWINGLY AND VOLUNTARILY WAIVES ITS JURY TRIAL RIGHTS FOLLOWING CONSULTATION WITH LEGAL COUNSEL. IN THE EVENT OF LITIGATION, A COPY OF THIS AMENDMENT MAY BE FILED AS A WRITTEN CONSENT TO A TRIAL BY THE COURT.
