**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS** (this “**Termination and Release**”), dated as of October 30, 2015, is by Gladstone Investment Corporation, a Delaware corporation, and Gladstone Capital Corporation, a Delaware corporation (collectively, together with their successors and assigns, the “**Secured Party**”), in favor of FUNKO LLC, a Washington limited liability company, located at 1202 Shuksan Way, Everett, Washington 98203 (the “**Grantor**”).

WITNESSETH:

**WHEREAS**, reference is made to (i) that certain Security Agreement, dated as of May 29, 2013 among the Secured Party, the Grantor and the other grantors named therein (as amended, restated, supplemented or otherwise modified from to the date hereof, the “**Security Agreement**”), (ii) that certain Grant of Trademark Security Interest, dated as of May 29, 2013, by the Grantor in favor of the Secured Party (the “**2013 Trademark Grant**”), and (iii) that certain Supplement No. 1 to Grant of Trademark Security Interest, dated as of December 9, 2014, among the Grantor and the Secured Party (the “**2014 Trademark Grant**”, together the 2013 Trademark Grant, the “**Trademark Grants**”) (all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement or the Trademark Grant, as applicable).

**WHEREAS**, pursuant to the terms and conditions of the Security Agreement and the Trademark Grants, the Grantor granted to the Secured Party a continuing security interest in all of its right, title and interest in and to certain collateral, including without limitation the trademark registrations and trademark applications set forth on Schedule A hereto, together with the goodwill associated therewith (collectively, the “**Trademark Collateral**”);

**WHEREAS**, the 2013 Trademark Grant was recorded with the U.S. Patent & Trademark Office on November 18, 2014 at Reel 5403 and Frame 0420;

**WHEREAS**, the 2014 Trademark Grant was recorded with the U.S. Patent & Trademark Office on December 10, 2014 at Reel 5416 and Frame 0811;

**WHEREAS**, the Secured Party now desires to terminate and release its security interest in and liens upon the Trademark Collateral; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

(a) the Secured Party hereby terminates, reassigns, releases and discharges any and all security interests and liens it has in the Trademark Collateral;


(b) if and to the extent that the Secured Party has acquired any right, title or interest to any of the Trademark Collateral, it hereby assigns and transfers such rights, title or interest to the Grantor; and

(c) the Secured Party shall take all further actions, and provide to the Grantor and each of its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Grantor as may be reasonably necessary to more fully and effectively effectuate the purposes of this Termination and Release, in each case at the expense of the Grantor.


