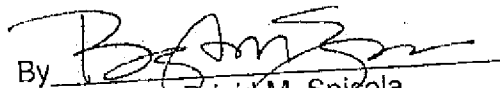
"1. The name of the Corporation is Optum Clinical Solutions, Inc."
