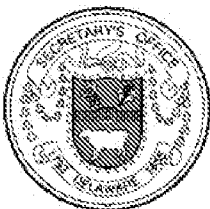

The undersigned, on behalf of American Builders & Contractors Supply Co., Inc., a corporation duly organized and existing under and by virtue of the laws of the State of Delaware (the "Corporation"), desiring to merge into itself Norandex Building Materials Distribution, Inc., a Delaware corporation and wholly owned Subsidiary of the Corporation (the "Subsidiary"), pursuant to the provisions of Section 253 of the General Corporation Law of the State of Delaware.

DOES HEREBY CERTIFY:

FIRST: The Corporation was incorporated pursuant to the provisions of the General Corporation Law of the State of Delaware on May 1, 1997.

SECOND: The Corporation owns 100% of the capital stock of the Subsidiary, a corporation organized pursuant to the provisions of the General Corporation Law of the State of Delaware on July 5, 2006.

THIRD: The Board of Directors of the Corporation, in a meeting held on August 11, 2015, adopted the resolutions set forth below authorizing and approving the merger of the Subsidiary with and into the Corporation.

MERGER WITH NORANDEX

WHEREAS, upon the closing of the stock purchase transaction approved above, the Corporation will be the sole holder of all of the issued and outstanding shares of capital stock of Norandex Building Materials Distribution, Inc., a Delaware corporation (the "Subsidiary");

WHEREAS, the Corporation desires that the Subsidiary be merged with and into the Corporation pursuant to Section 253 of the DGCL and to be possessed of all the estate, property, rights, privileges and franchises of the Subsidiary, with the Corporation being the surviving corporation (the "Merger"); and

WHEREAS, the Corporation deems it advisable and in the best interest of the Corporation to consummate the Merger.

NOW, THEREFORE, BE IT RESOLVED, that the Board hereby authorizes and approves the Merger.

FURTHER RESOLVED, that by virtue of the Merger and without any action on the part of the holder thereof, each then outstanding share of capital stock of the Corporation shall remain unchanged and continue to remain outstanding as one share of the same class or series of capital stock of the Corporation held by the person who was the holder of such share of capital stock of the Corporation immediately prior to the Merger.

FURTHER RESOLVED, that by virtue of the Merger and without any action on the part of the holder thereof, each then outstanding share of capital stock of the Subsidiary shall be cancelled and no consideration shall be issued in respect thereof.

FURTHER RESOLVED, that the certificate of incorporation of the Corporation as in effect immediately prior to the effective time of the Merger shall be the certificate of incorporation of the Corporation, as the surviving corporation of the Merger.

FURTHER RESOLVED, that any authorized officer of the Corporation (the "Authorized Officers") be, and each hereby are, directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolution to merge the Subsidiary with and into the Corporation, and to file the same (together with such changes therein or modifications thereto as such Authorized Officer shall in his or her sole discretion deem necessary, proper or advisable) in the office of the Secretary of State of Delaware.

FURTHER RESOLVED, that the Authorized Officers of the Corporation be, and each hereby is, authorized and directed to take all further actions, whether within or without the State of Delaware, which may be in any way necessary or proper to effect the Merger.

GENERAL

FURTHER RESOLVED, that any acts of the Board or any Authorized Officer or of any person or persons designated and authorized to act by an Authorized Officer, which acts would have been authorized by the foregoing resolutions except that such acts were taken prior to the adoption of such resolutions, are hereby severally ratified, confirmed, approved and adopted as acts in the name and on behalf of the Corporation.

FURTHER RESOLVED, that in order to fully carry out the intent and effectuate the purposes of the foregoing resolutions, the Authorized Officers be, and each hereby is, authorized to take all such further actions in order to effect the Merger and to execute and deliver all such further agreements, instruments, documents or certificates, in the name and on behalf of the Corporation, and under its corporate seal or otherwise, and to pay all such fees and expenses, which shall in their judgment be necessary, proper or advisable and to perform all of the obligations of the Corporation.

**FOURTH:** The Corporation shall be the surviving corporation of the Merger.

**FIFTH:** The certificate of incorporation of the Corporation as in effect immediately prior to the effective time of the Merger shall be the certificate of incorporation of the Corporation, as the surviving corporation of the Merger.

**SIXTH:** The Merger shall be effective on November 1, 2015 at 12:01 a.m. Eastern Daylight Time.
