**SECOND AMENDMENT TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Second Amendment to Intellectual Property Security Agreement (this "Second Amendment") is made as of the 3rd day of November, 2015 by and among (a) each of the Persons listed on Schedule I hereto (each such Person, individually, a "Borrower" and, collectively, the "Borrowers"), (b) each of the Persons listed on Schedule II hereto (each such Person, individually, a "Guarantor" and, collectively, the "Guarantors") (the Borrowers and the Guarantors are hereinafter referred to, individually, as a "Grantor" and, collectively, as the "Grantors"), and (c) BANK OF AMERICA, N.A., a national banking association, as collateral agent (in such capacity, the "Collateral Agent") for its own benefit and the benefit of the other Credit Parties (as defined in the Credit Agreement referred to below), in consideration of the mutual covenants contained herein and benefits to be derived herefrom.

WITNESSETH:

WHEREAS, reference is made to that certain Second Amended and Restated Credit Agreement, dated as of May 17, 2012 (as amended, modified, supplemented or restated and in effect from time to time, the "Credit Agreement"), by and between, among others, (i) the Grantors, (ii) Bank of America, N.A., as administrative agent (in such capacity, the "Administrative Agent") for its own benefit and the benefit of the other Credit Parties, (iii) the Collateral Agent, (iv) Wells Fargo Bank, National Association, as FILO Agent, and (v) the lenders from time to time party thereto (individually, a "Lender" and, collectively, the "Lenders"), pursuant to which the Lenders have agreed to make Loans to the Borrowers, and the L/C Issuer has agreed to issue Letters of Credit for the account of the Borrowers, upon the terms and subject to the conditions specified in the Credit Agreement;

WHEREAS, as a condition to the Lenders agreeing to make Loans and to the L/C Issuer agreeing to issue Letters of Credit, the Lenders required, among other things, that the Grantors execute and deliver that certain Intellectual Property Security Agreement, dated as of May 3, 2006 and filed with the US Patent and Trademark Office (the "USPTO") on May 15, 2006 at Reel 3308, Frame 633, as amended by that certain First Amendment to Intellectual Property Security Agreement dated as of February 23, 2010 and filed with the USPTO on March 24, 2010 at Reel 4173, Frame 677 (as amended, modified, supplemented or restated and in effect from time to time, the "IP Security Agreement"), by and among the Grantors and the Collateral Agent, pursuant to which each Grantor granted to the Collateral Agent (for its own benefit and the benefit of the other Credit Parties) a security interest in and to the IP Collateral (as defined therein), in order to secure the Secured Obligations (as defined therein); and

WHEREAS, the Grantors and the Collateral Agent now wish to amend, modify and supplement the IP Security Agreement to include the additional Trademarks and Patents, as more particularly set forth in this Second Amendment.

NOW, THEREFORE, in consideration of the premises contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Definitions. All capitalized terms used herein and not otherwise defined shall have the same meaning herein as in the IP Security Agreement or the Credit Agreement (as applicable).
2. Amendment to Exhibit B. **EXHIBIT B** to the IP Security Agreement is hereby supplemented to include the Patents more particularly described on **EXHIBIT B-2** attached hereto. For purposes of clarity, such **EXHIBIT B-2** shall be deemed to supplement, rather than replace, **EXHIBIT B** annexed to the IP Security Agreement.
3. Amendment to Exhibit C. **EXHIBIT C** to the IP Security Agreement is hereby supplemented to include the Trademarks more particularly described on **EXHIBIT C-2** attached hereto. For purposes of clarity, such **EXHIBIT C-2** shall be deemed to supplement, rather than replace, **EXHIBIT C** annexed to the IP Security Agreement.
4. Effect on IP Security Agreement. Except as otherwise expressly provided herein, all of the terms and conditions of the IP Security Agreement remain in full force and effect. Each of the Grantors hereby ratifies, confirms, and reaffirms that all of the representations and warranties of the Grantors contained in the IP Security Agreement are true and correct in all material respects on and as of the date hereof, except to the extent that such representations and warranties specifically refer to an earlier date, in which case they are true and correct in all material respects as of such earlier date.
5. Counterparts. This Second Amendment may be executed in several counterparts and by each party on a separate counterpart, each of which when so executed and delivered, each shall be an original, and all of which together shall constitute one instrument. Delivery of an executed counterpart of a signature page hereto by telecopy or e-mail of a PDF copy shall be effective as delivery of a manually executed counterpart hereof.
6. Entire Agreement. This Second Amendment expresses the entire understanding of the parties with respect to the transactions contemplated hereby. No prior negotiations or discussions shall limit, modify, or otherwise affect the provisions hereof.
7. Severability. Any provision of this Second Amendment held to be invalid, illegal or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such invalidity, illegality or unenforceability without affecting the validity, legality and enforceability of the remaining provisions hereof, and the invalidity of a particular provision in a particular jurisdiction shall not invalidate such provision in any other jurisdiction.
8. Consultation with Counsel. Each of the Grantors represents and warrants that it has consulted with independent legal counsel of its selection in connection with this Second Amendment and is not relying on any representations or warranties of the Collateral Agent or the Lenders or their counsel in entering into this Second Amendment.
9. Governing Law. This Second Amendment shall be construed, governed, and enforced pursuant to the laws of the State of New York.

10. Further Assurances. Each Grantor agrees, at its own expense, to execute, acknowledge, deliver and cause to be duly filed all such further documents, financing statements, agreements and instruments and take all such further actions as the Collateral Agent may from time to time reasonably request to better assure, preserve, protect and perfect the security interest in the IP Collateral granted pursuant to the IP Security Agreement, as amended, modified and supplemented pursuant to this Second Amendment and the rights and remedies created hereby or the validity or priority of such security interest, including the payment of any fees and taxes required in connection with the execution and delivery of this Second Amendment, the granting of the security interest and the filing of any financing statements or other documents in connection herewith or therewith.


