SECURITY INTEREST IN TRADEMARKS**

**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**, dated as of October 27, 2015 (this "Termination"), by **Marsh Merger Sub, LLC**, the ("Secured Party") and **GPM Southeast, LLC** and each other person identified on the signature pages thereof as a "Grantor" (each a "Grantor" and collectively, the "Grantors") in connection with that Trademark Security Agreement, dated as of August 6, 2013 (as may have been amended, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Agreement"), by and among Worsley Operating Company, LLC ("Worsley") and the Grantors.

**WHEREAS**, pursuant to the terms of the Trademark Agreement, the Grantors granted to Worsley a security interest in the trademarks identified on Exhibit A attached hereto (the "Trademarks");

**WHEREAS**, Worsley assigned its security interest in the Trademarks to WOC Southeast Holding Corp. ("WOC Southeast") pursuant to that certain Confirmation of Trademark Security Interest Assignment, dated as of January 30, 2014, among Worsley and WOC Southeast;

**WHEREAS**, WOC Southeast assigned its security interest in the Trademarks to the Secured Party pursuant to that certain Confirmation of Trademark Security Interest Assignment, dated as of January 30, 2014 between WOC Southeast and the Secured Party; and

**WHEREAS**, the Secured Party has agreed to terminate and release its security interest in the Trademarks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates, releases and discharges all of the Secured Party's security interest in the Trademarks of the Grantors, including, without limitation, the trademarks listed on Exhibit A attached hereto, effective as of the date set forth above.

The parties hereto hereby acknowledge that this document may be filed along with any other necessary documentation with the United States Patent and Trademark Office, to evidence the termination and release granted herein.

This Termination shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to its conflicts of law principals.
