RELEASE OF SECURITY INTEREST AND ASSIGNMENT OF RIGHTS

Craig Ramsell, an individual residing at 50 Bronco Drive, Sedona, Arizona 86336 ("Ramsell") and Rhythm Band Instruments, LLC, a Texas limited liability company having offices at 1227 W. Magnolia Ave., Suite 300, Fort Worth, Texas 76104 ("RBI") entered into that certain Pledge Agreement dated July 12, 2009, wherein RBI granted to Ramsell a security interest in certain intellectual property ("Intellectual Property"), including, without limitation:

- a) U.S. Patent No. 5,814,747, issued September 29, 1998 to Ramsell, and entitled "Percussion Instrument Capable of Producing a Musical Tone";
- b) U.S. Design Patent No. D548,955, originally issued on August 21, 2007 to Whacky Music, Inc. and entitled "Carrying Case for Musical Instrument";
- c) U.S. Trademark Registration No. 2,200,973, for "BOOMWHACKERS" originally granted November 3, 1998 to Ramsell for use on musical instruments, in particular percussion instruments in Intl. Class 15;
- d) Common law trademark rights listed in Exhibit C to the Purchase Agreement;
- e) Domain name rights listed in Exhibit J to the Purchase Agreement;
- f) The entire goodwill associated with such trademarks and domain names; and
- g) Proceeds therefrom.

Pursuant to that certain Agreement to Assignment of Rights under Patent and Trademark Purchase Agreement, Ramsell and RBI agreed that all rights held by Ramsell under the Pledge Agreement were transferred to and assigned to Stratcap Investments, Inc., a Delaware corporation, having offices at 100 Sheppard Avenue East, Suite 720, Toronto, Ontario M2N 6N5, Canada ("SCI"), to secure collection of certain payments owed by RBI to Ramsell. Ramsell and RBI provided notice of such assignment by way of that certain Notice of Assignment of Rights Under Pledge Agreement, recorded in the United States Patent and Trademark Office, with the corresponding recording cover page describing the Nature of Conveyance as "Assigns the Entire Interest and Goodwill", said recording being at Reel 5013, Frame 0311 for the trademarks and at Reel 30277, Frame 755 for the patents.

Ramsell and SCI acknowledge that all payments under the Pledge Agreement have been made and Ramsell and SCI are fully satisfied. Ramsell and SCI hereby completely release and forever discharge RBI, its assigns, successors, officers, directors, employees, agents, and heirs from any and all claims arising from the Pledge Agreement and hereby release all of the Intellectual Property referred to in the Pledge Agreement and assign all of their interest in the Intellectual Property to RBI.
