## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of October 30, 2015 (the "Effective Date") by REGIONS BANK, an Alabama banking corporation, as Collateral Agent, with its principal office at 150 4<sup>th</sup> Ave North, Nashville, Tennessee 37219 ("Grantee"), in favor of AKESO CARE MANAGEMENT, INC., an Indiana corporation, with its principal office at 2960 North Meridian Street, Indianapolis, IN 46208-4715 ("Grantor").

**WHEREAS**, pursuant to the terms and conditions of: that certain Grant of Security Interest Trademarks by and between Grantor and Grantee dated August 30, 2012 (the "Trademark Security Agreement"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all of the trademarks, trademark registrations, trademark applications, trademark licenses and all renewals thereof and all proceeds of the foregoing, including, without limitation, the trademark registrations and applications set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith (collectively, the "Trademarks");

**WHEREAS**, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Security Agreement by and between Grantor, Grantee and the other parties thereto dated August 30, 2012 (the "Security Agreement");

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the "PTO") on October 3, 2012 at Reel/Frame 004871/0813; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those Trademarks set forth on Schedule A, in any jurisdiction throughout the world, other than such filings made in the PTO or financing statements filed in connection with the Security Agreement.

Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

IN WITNESS WHEREOF, Grantee has caused this Release to be executed by its duly authorized representative as of the Effective Date.
