**TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Termination"), is dated as of November 5, 2015 and made by **Suntrust Bank**, a Georgia corporation (the "Secured Party") to **Barbeque Integrated, Inc.**, a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Intellectual Property Collateral Assignment and Security Agreement dated as of June 4, 2013, made by the Grantor in favor of the Secured Party (the "Security Agreement"), a security interest was granted by the Grantor to the Secured Party in certain collateral;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on June 5, 2013, at Reel 005041 and Frame 0341; and

WHEREAS, the Secured Party now desires to terminate and release the Security Agreement and all liens granted pursuant thereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Secured Party hereby agrees as follows.

1. Definitions. All defined terms used herein but not defined herein shall have the definitions ascribed to them in the Security Agreement.

2. Release of Security Interest. The Secured Party hereby (i) terminates the Security Agreement, (ii) terminates, releases, and discharges its security interest in and lien upon the Collateral, including the Intellectual Property set forth on Schedule A, and (iii) reassigns, grants, and conveys to Grantor, without recourse, representation or warranty, all of Secured Party's right, title and interest (if any) in the Collateral and the goodwill of Grantor's business connected with the use and symbolized by the Collateral.
