

This Assignment Agreement shall be binding upon and inure to the benefit of the parties and their respective successors and assigns.

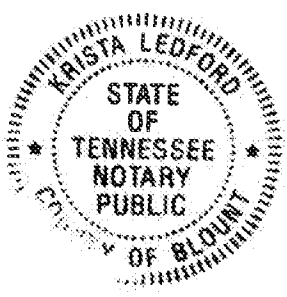
