TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Virgil Gamache Farms, Inc., a Washington corporation, whose address is 6371 Fort Road, Toppenish, WA 98948 (hereinafter "Assignor"), has filed and owns an intent-to-use trademark application in the United States Patent and Trademark Office for the trademark LUPA LINN, Serial No. 86/236,105 filed March 28, 2014 (hereinafter the "Mark"); and,

WHEREAS, Lupa Linn Adventures LLC, a Washington limited liability company, whose address is 2013 S. 87th Avenue, Yakima, Washington 98908 (hereinafter "Assignee"), is desirous of acquiring all rights in said Mark and in the '105 Application, together with the goodwill of the business associated therewith.

NOW, THEREFORE, for good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby:

- 1. Assignor hereby assigns, transfers and conveys to Assignee, Assignor's entire right, title and interest in and to said Mark and the '105 Application, together with the goodwill of Assignor's business associated therewith;
- 2. Assignor hereby assigns to Assignee all causes of action, claims and rights to damages or profits, due or accrued, arising out of past infringement of the Mark and the '105 Application, or injury to the goodwill associated with the Mark and the '105 Application, as well as the rights to sue for and recover the Mark and the '105 Application in Assignee's own name; and
- 3. Assignor represents and warrants that it will reasonably cooperate (i) in any actions necessary for Assignee to prosecute, renew or register its rights, title and interests in and to the Mark and the '105 Application, including United States and foreign registrations, at Assignee's expense, and (ii) in any actions brought to enforce the rights accompanying this Assignment against third parties, at Assignee's expense.
- 4. Assignor hereby authorizes and requests the PTO to issue the certificate of registration in respect of the '105 Application to Assignee for its sole use, and for the use of its legal representatives and assigns, to the full end of the term for which such registration may be granted, as fully and entirely as the same would have been held by Assignor had this assignment not been made.
