2. Covenant to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers and take any actions necessary to perfect and vest such rights, title and interest in Assignee, its successors, assigns and legal representatives.

3. As of the transfer date, Assignors hereby authorize the Commissioner of Patent and Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office, to transfer ownership of U.S. Trademark Registration No. 4,132,120 and U.S. Trademark Registration No. 4,132,119 to SJJ Banking Formation LLC as assignee of the entire right, title and interest therein or otherwise in accordance with this Assignment.

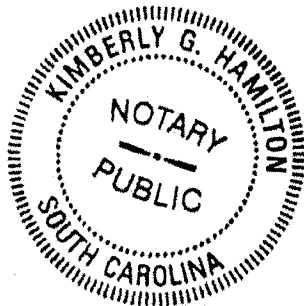
