SUPPLEMENT NO. 2 TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Supplement No. 2 to Intellectual Property Security Agreement (this "Supplement") is made as of November 4, 2015, by and between VIEWPOST IP HOLDINGS, LLC ("Grantor"), and VENTURE LENDING & LEASING VII, INC. ("Secured Party").

RECITALS

AGREEMENT

Exhibit A to Intellectual Property Security Agreement, the listing of Grantor's Copyrights, is hereby supplemented and amended by Exhibit "A" attached to this Supplement, to include reference to Grantor's right, title and interest in, to and under the Copyrights set forth thereon. Exhibit C to Intellectual Property Security Agreement, the listing of Grantor's Trademarks, is hereby supplemented and amended by Exhibit "C" attached to this Supplement, to include reference to Grantor's right, title and interest in, to and under the Trademarks set forth thereon.

2. This Supplement shall be deemed to be an amendment to Intellectual Property Security Agreement and shall not be construed in any way as a replacement or substitution therefor. All of the terms and conditions of, and terms defined in, this Supplement are hereby incorporated by reference into the Intellectual Property Security Agreement as if such terms and provisions were set forth in full therein. Except as so amended hereby, the Intellectual Property Security Agreement and the other Loan Documents shall remain in full force and effect in accordance with their respective terms.
