**TERMINATION AND RELEASE
OF TRADEMARK SECURITY AGREEMENTS**

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS ("Release"), dated as of October 30, 2015 by and between BLACK LETTER DISCOVERY, INC., a California corporation (the "Grantor") and WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, under the Loan Agreement and Pledge Agreement as defined in the Trademark Agreements defined below (the "Lender").

Recitals

WHEREAS, pursuant to the terms of the Trademark Security Agreement dated June 7, 2012 and the Intellectual Property Security Agreement dated June 7, 2012, each by and between the Grantor and the Lender, and respectively recorded with the United States Patent and Trademark Office on June 13, 2012 (Trademark Reel 4800 and Frame Number 0387) and June 18, 2012 (Trademark Reel 4803 and Frame Number 0097) (collectively, the "Trademark Agreements") for the purpose of securing certain obligations of the Grantor to the Lender;

WHEREAS, pursuant to the grant of the security interest in its trademarks, the Grantor granted to the Lender, a security interest in and lien on, several of its trademarks, identified on Schedule 1, attached hereto (such trademarks referred to herein as the "Named Trademarks");

WHEREAS, the Lender terminated and released its security interest and all of its right, title and interest in each of the Named Trademarks as herein provided.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender and the Grantor hereby agree as follows:

1. Incorporation of Recitals. The recitals are material to this Release, are true and correct and are adopted as part of this Release.
2. Release and Assignment. The Lender hereby irrevocably and unconditionally terminates and releases its security interest in and lien on all of the Named Trademarks and the Lender hereby assigns and transfers to the Grantor, without recourse, all of the Lender's right, title and interest in and to each of the Named Trademarks effective as of the date set forth above.
3. Acknowledgment and Acceptance. The Grantor hereby acknowledges and accepts the foregoing release and assignment by the Lender.
4. Counterparts. This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.
5. Further Assurances. The Lender, agrees to authenticate and deliver to the Grantor or its counsel such other writings or records and make and do all such other and further acts or things as the Grantor or its counsel shall deem necessary or advisable to effectuate or better evidence the agreements contained in this Release.

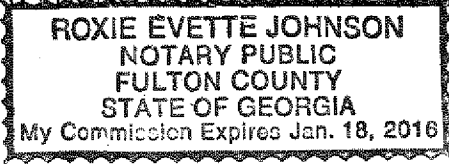
