The name of this Limited Liability Company (hereinafter, the "LLC") shall be:

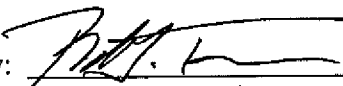

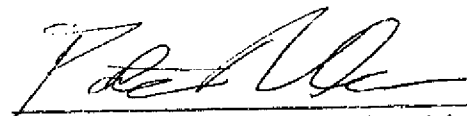
