1. They are the President and Secretary of THE COACHES TRAINING INSTITUTE., a California Corporation (the "Corporation").


2. Article I of the Articles of Incorporation of the corporation is amended to read as follows:


**"ARTICLE I**

The total number of outstanding shares of the corporation is 11,477. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% and this amendment was approved by the affirmative vote of 92.4% of the outstanding shares.


