

COMMISSIONER

Pursuant to the provisions of Sections 32.101 and 32.008 of the Texas Finance Code and Article 4.04 of the Texas Business Corporation Act, the undersigned state bank adopts the following Amendment to its Articles of Association (the "Amendment").

1. **NAME.**

The name of the association is: **First State Bank** (the "Bank").

2. **ADOPTION OF AMENDED ARTICLE.**

The following Amendment to the Articles of Association was adopted by the Sole Shareholder of the Bank on **April 16, 2004**.

3. **AMENDED ARTICLE.**

The Amendment alters or changes Article I of the original or amended articles of association of the Bank and the full text of Article I as altered is as follows:

"ARTICLE I

The title of this Association shall be Happy State Bank."

4. **ENTITLED TO VOTE.**

The number of shares of the Bank outstanding at the time of such adoption was 2,000 and the number of shares entitled to vote thereon was 2,000.

5. **VOTING.**

The sole shareholder of all of the issued and outstanding shares of the Bank entitled to vote on the Amendment has signed a consent in writing pursuant to Article 9.10 of the Texas Business Corporation Act adopting said Amendment and any written notice required by Article 9.10 has been given.

6. **EXCHANGE, RECLASSIFICATION OR CANCELLATION OF SHARES.**

The Amendment does not provide for an exchange, reclassification or cancellation of issued shares.

7. **CHANGE IN CAPITAL OR SURPLUS**

The amendment does not effect a change in capital or surplus.


