**RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”), is made as of the 10th day of November, 2015 by Bank of America, N.A., as administrative agent (in such capacity, together with its successors and assigns, the “Administrative Agent”) for the Secured Parties, as such term is defined in the Credit Agreement described below, in favor of Remy Technologies, L.L.C., a Delaware limited liability company; Remy Holdings, Inc. (formerly named Remy International, Inc.), a Delaware corporation; Remy Inc., a Delaware corporation; Reman Holdings, L.L.C., a Delaware limited liability company; Remy Electric Motors, L.L.C., a Virginia limited liability company; World Wide Automotive, L.L.C., a Virginia limited liability company; Maval Industries, L.L.C., a Delaware limited liability company; Remy USA Industries, L.L.C., a Delaware limited liability company; Fidelity National Technology Imaging, L.L.C., a Delaware limited liability company; and Remy International Holdings, Inc., a Delaware corporation (collectively, jointly and severally, the “Grantors”).

WHEREAS, Remy Holdings, Inc. (formerly named Remy International, Inc.), the Lenders from time to time party thereto and the Administrative Agent entered into the Term B Loan Credit Agreement, which was amended and restated on March 5, 2013 and December 31, 2014 (as amended, restated, supplemented or otherwise modified from time to time, collectively the “Credit Agreement”);

WHEREAS, on December 17, 2010, the Grantors, the Administrative Agent and other grantors named therein, entered into the Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the terms and conditions of the Security Agreement, the Grantors executed and delivered to Administrative Agent, a series of Grant of Trademark Security Interests and IP Security Agreement Supplement referenced below for recording with the United States Patent and Trademark Office (the “U.S.P.T.O.”) (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, collectively the “Trademark Security Agreements”);

WHEREAS, pursuant to the terms and conditions of the Security Agreement and Trademark Security Agreements, the Grantors granted a security interest in favor of the Administrative Agent, and the Administrative Agent became a secured creditor with respect to, certain intellectual property of the Grantors, including the Trademark Collateral (as defined below);

WHEREAS, pursuant to the Grant of Trademark Security Interest, Remy Holdings, Inc. (formerly Remy International, Inc.) granted to the Administrative Agent a security interest in trademarks executed on December 17, 2010 and recorded on December 20, 2010 at Reel No. 4470 and Frame No. 0676 in the U.S.P.T.O. (the “First Trademark Security Agreement”);

WHEREAS, pursuant to the Grant of Trademark Security Interest, Remy Inc. granted to the Administrative Agent a security interest in trademarks executed on December 17, 2010 and recorded on December 20, 2010 at Reel No. 4470 and Frame No. 0686 in the U.S.P.T.O. (the “Second Trademark Security Agreement”);

WHEREAS, pursuant to the Grant of Trademark Security Interest, World Wide Automotive, L.L.C. granted to the Administrative Agent a security interest in trademarks executed on December 17, 2010 and recorded on December 20, 2010 at Reel No. 4437 and Frame No. 0375 in the U.S.P.T.O. (the “Third Trademark Security Agreement”);

WHEREAS, pursuant to the IP Security Agreement Supplement, Remy Holdings, Inc. (formerly Remy International, Inc.); Remy Inc.; Remy Technologies, L.L.C.; Reman Holdings, L.L.C.; and Remy Electric Motors, L.L.C. granted to the Administrative Agent a security interest in trademarks executed on March 5, 2013 and recorded on March 5, 2013 at Reel No. 4975 and Frame No. 0040 in the U.S.P.T.O. (the “Fourth Trademark Security Agreement”);

WHEREAS, pursuant to the Grant of Trademark Security Interest, Remy USA Industries, L.L.C. granted to the Administrative Agent a security interest in trademarks executed on February 11, 2014 and recorded on June 30, 2014 at Reel No. 5312 and Frame No. 0388 in the U.S.P.T.O. (the “Fifth Trademark Security Agreement”);

WHEREAS, pursuant to the Grant of Trademark Security Interest, Fidelity National Technology Imaging, L.L.C. granted to the Administrative Agent a security interest in trademarks executed on January 5, 2015 and recorded on January 5, 2015 at Reel No. 5434 and Frame No. 0540 in the U.S.P.T.O. (the “Sixth Trademark Security Agreement”);

WHEREAS, pursuant to the Grant of Trademark Security Interest, Maval Industries, L.L.C. and Remy International Holdings, Inc. granted to the Administrative Agent a security interest in trademarks executed on April 2, 2015 and recorded on April 21, 2015 at Reel No. 5501 and Frame No. 0615 in the U.S.P.T.O. (the “Seventh Trademark Security Agreement”); and

WHEREAS, the Administrative Agent, on behalf of itself and the Secured Parties, has agreed to relinquish and release any and all rights it may have in the Trademark Collateral set forth in the Trademark Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself and the Secured Parties, hereby states as follows:

1. DEFINED TERMS. All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or, if not defined therein, in the Credit Agreement.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and forever discharges, without recourse or warranty, all of its right, title, claim and interest in and to: (i) all of Grantors' trademarks and trademark applications, including those listed on Schedule A attached hereto, and all goodwill of such Grantor's business that is connected with the use of, and symbolized by, such trademarks; (ii) all renewals and extensions of the foregoing; (iii) all rights (but not obligations) corresponding to the foregoing to sue for past, present and future infringements; and (iv) all proceeds, products, rents, profits from and other payments now or hereafter due and payable with respect to, any and all of the foregoing (collectively, the "Trademark Collateral").

3. Further Assurances. The Administrative Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.

4. Authorization. The Administrative Agent hereby authorizes and requests the Commissioner of Trademarks of the United States to record this Release.

5. General Provisions.

- a. This Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors and assigns.
- b. All rights hereunder shall accrue to, and all obligations hereunder shall be binding upon, the heirs, representatives, successors, assigns and transferees of the parties hereto.
- c. This Release may be executed in any number of separate counterparts, each of which, when so executed, shall be deemed an original, and all of said counterparts taken together shall be deemed to constitute but one and the same instrument.
- d. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.


