PURPOSE: In order to amend a Limited Liability Company's (LLC) Certificate of Formation/Articles of Organization under Section 10A-1-3.13 and 10A-5-2.03 of the Code of Alabama 1975 this Amendment and the appropriate filing fees must be filed with the Office of the Judge of Probate in the county where the LLC was initially formed/ incorporated.

ARTICLE II is amended and replaced to read as follows:

"ARTICLE II

The Company was converted into a limited liability company from International Enterprises, Inc., an Alabama corporation (the "Converting Entity"), effective as of the filing of the Articles of Dissolution with the probate judge in Jefferson County, Alabama and this Certificate of Formation with the probate judge in Montgomery County, Alabama. The Converting Entity was first organized as an Alabama corporation on August 26, 1969. The address of the Converting Entity is 108 Allen Street, Talladega, Alabama 35160."
