Said Mark and registration therefor are to be held and enjoyed by ASSIGNEE for its own use and for its successors, assigns, and other legal representatives, the same as would have been held and enjoyed by ASSIGNOR had this Assignment not been made.

IN WITNESS WHEREOF, ASSIGNOR and ASSIGNEE have caused this Assignment to be executed by their respective duly authorized representatives.




