RELEASE OF TRADEMARK SECURITY INTEREST

The Administrative Agent hereby releases, retransfers and reassigns to the Obligors, as applicable, the security interest and all of the Administrative Agent's right, title and interest in, to and under the Released Collateral. The Administrative Agent will take all such further actions, execute and deliver, at the request and cost of the Obligors, such further instruments, documents and release forms as any Obligor may reasonably request or are required to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.


