RELEASE OF SECURITY INTERESTS

This release ("Release") is executed by Comerica Bank, a Texas banking association, successor by merger to Comerica Bank, a Michigan banking corporation, with an office in Detroit, Michigan ("Releasor") to and for the benefit of Quanex Building Products Corporation, a Delaware corporation with an office located at 1800 West Loop S., Ste 1500, Houston, TX 77027 ("Quanex Building Products"), as assignee of certain interests from Quanex Corporation, a Delaware corporation with an office located at 1800 West Loop S., Ste 1500, Houston, TX 77027 ("Quanex Corp."). Quanex Building Products and Quanex Corp. are collectively referred to herein as "Releasee."

WHEREAS, Quanex Corp. is a party to that certain Security Agreement dated November 26, 2002, recorded with the United States Patent and Trademark Office, Reel/Frame: 002679/0858 ("Security Agreement"), which references that certain Quanex Corporation Revolving Credit Agreement dated November 26, 2002 ("Credit Agreement"), and Quanex Corp., by and through the Security Agreement, executed a security interest in favor of Releasor to certain properties.

WHEREAS, Quanex Corp. assigned its interests in certain trademarks, including the registrations identified on Schedule A, to Quanex Building Products, pursuant to that certain Assignment dated April 23, 2008, recorded with the United States Patent and Trademark Office, Reel/Frame: 003770/0614 ("Assignment").

WHEREAS, Releasee has satisfied its conditions for release of all such security interests under the Security Agreement, and Releasor acknowledges the same.

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, including the satisfaction by release of all obligations under the Security Agreement between Releasor and Releasee; Releasor, on behalf of itself and as Agent under the Security Agreement and Credit Agreement, hereby acknowledges

and affirms the release of, and releases, the security interests previously conveyed to it by Releasee in the Security Agreement for the intellectual property collateral (e.g., patents, trademarks, copyrights) of Releasee, whether registered or unregistered, including the trademarks listed on Schedule A, and all proceeds (such as license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements rights throughout the world, and all reissues, divisions, continuations, renewals, extensions and continuations-in-part.

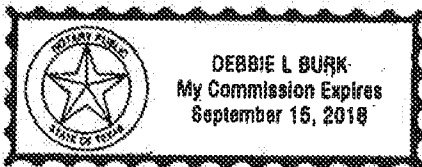
