**TERMINATION AND RELEASE OF SECURITY INTEREST IN
CERTAIN U.S. TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN CERTAIN U.S. TRADEMARKS (the "***Trademark Termination and Release***") dated as of November 9, 2015, from BANK OF AMERICA, N.A. (successor by merger of LaSalle Bank National Association), in its capacity as collateral agent (the "***Collateral Agent***") pursuant to the Security Agreements as more particularly described below.

WITNESSETH:

WHEREAS, pursuant to a Collateral Trademark Security Agreement dated as of the first day of July 2001 (the "***2001 Security Agreement***") and a HV Enhancement Guaranty Collateral Trademark Security Agreement dated as of the 25th day of July, 2003 (the "***2003 Security Agreement***" and, together with the 2001 Security Agreement, collectively the "***Security Agreements***"), between Hunt Valve Company, Inc. (hereinafter referred to as the "***Grantor***") and the Collateral Agent, a security interest (the "***Security Interest***") was granted by the Grantor to the Collateral Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, the 2001 Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 11, 2003 at Reel 002687, Frame 0119, including but not limited to those trademarks set forth on Schedule I attached hereto; and

WHEREAS, the 2003 Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 1, 2003 at Reel 002792, Frame 0551, including but not limited to those trademarks set forth on Schedule I attached hereto; and

WHEREAS, the Collateral Agent has agreed to release its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Definitions. The term "***Specified Trademark Collateral***", as used herein, shall mean the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks described on Schedule I attached hereto.


2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral described on Schedule I hereto without representation, warranty or recourse of any kind or nature. Except for the foregoing release of the Security Interest in the Specified Trademark Collateral, no other lien or

security interest on the Grantor's assets (including other trademarks and trademark applications) in favor of the Collateral Agent is released or terminated.

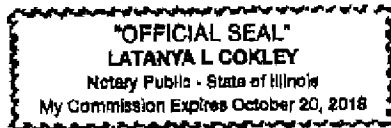


