**ASSIGNMENT OF TRADEMARKS**

Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Contribution Agreement.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, (a) each of the Assignors hereby sells, conveys, grants, assigns, transfers and delivers unto Holdings, One Hundred Percent (100%) of each Assignor's right, title and interest in and to the Trademarks (the "First Assignment") and (b) immediately following the First Assignment, Holdings hereby sells, conveys, grants, assigns, transfers and delivers unto Company and its successors and assigns, One Hundred Percent (100%) of Holdings' right, title and interest in and to the Trademarks.

For purposes of this Assignment of Trademarks, the "Trademarks" shall mean the entire right, title and interest in and to the trademarks which are owned or controlled by an Assignor, including without limitation, the Trademarks which are set forth on Schedule A attached hereto (or if not set forth on Schedule A, those Trademarks which are otherwise deemed Trademarks pursuant to the Contribution Agreement), throughout the world, whether registered or unregistered, and the U.S. and foreign registrations and applications for registration thereof, all renewals and extensions thereof, and all common law rights relating thereto, together with all translations, adaptations, modifications, derivations and combinations thereof, and including all goodwill associated therewith throughout the world, and the right to sue and recover for infringements arising prior to, on or after the Effective Date.

Nothing herein shall be construed to modify or vitiate or expand the terms and conditions of the Contribution Agreement. To the extent there is any conflict between any provisions of this Assignment of Trademarks and any provisions of the Contribution Agreement, the provisions of the Contribution Agreement shall control.

This agreement shall inure to the benefit of and be binding upon the parties hereto and their respective successors and permitted assigns.

This agreement shall in all respects be governed by, and construed in accordance with, the Laws (excluding conflict of laws rules and principles) of the State of Delaware applicable to agreements made and to be performed entirely within such State, including all matters of construction, validity and performance.

This agreement may be executed by facsimile signatures, or by signatures transmitted by electronic means intended to preserve the original graphic and pictorial appearance thereof, and in as many counterparts as may be required. All counterparts shall collectively constitute one and the same document.
