**FIRST CERTIFICATE OF AMENDMENT  
TO THE  
FIFTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF  
HF GLOBAL, INC.**

**(Pursuant to Section 242 of the  
General Corporation Law of the State of Delaware)**

HF Global, Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the “*General Corporation Law*”),

**DOES HEREBY CERTIFY:**

**FIRST:** That the name of this corporation is HF Global, Inc. (the “*Corporation*”) and that the Corporation was originally incorporated pursuant to the General Corporation Law on February 7, 2012 under the name ADKM, Inc.

**SECOND:** That the Board of Directors of the Corporation adopted resolutions setting forth proposed amendments to the Fifth Amended and Restated Certificate of Incorporation of the Corporation (the “*Restated Certificate*”), declaring said amendments to be advisable and in the best interests of the Corporation and its stockholders and authorizing the appropriate officers of the Corporation to solicit the consent of the stockholders therefor, which resolutions setting forth the proposed amendments are substantially as follows:

**RESOLVED**, that Article I of the Restated Certificate be deleted and replaced in full with the following:

**“ARTICLE I**

The name of the Corporation is Harry’s, Inc.”

**THIRD:** That thereafter said amendments were duly adopted in accordance with the provisions of Section 242 of the General Corporation Law by written consent of the stockholders holding the requisite number of shares required by statute given in accordance with and pursuant to Section 228 of the General Corporation Law.

**IN WITNESS WHEREOF**, HF Global, Inc. has caused this First Certificate of Amendment to the Fifth Amended and Restated Certificate of Incorporation to be executed by a duly authorized officer of the Corporation on this 12th day of November, 2015.
