**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

October 14, 2015

WHEREAS **F+W Media, Inc.**, a Delaware corporation with principal offices at 38 E. 29th St., New York, NY 10016 (the "Grantor"), entered into a certain Grant of First Lien Security Interest in Trademark Rights dated July 9, 2013 (the "Trademark Security Agreement") with **Macquarie US Trading LLC**, a limited liability company with principal offices at 125 West 55th Street, New York, NY 10019 (the "Administrative Agent"), notice of which was recorded on July 19, 2013 at the United States Patent and Trademark Office at Reel 5074, Frame 0654.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Administrative Agent, in and to certain of Grantor's trademarks, including without limitation the trademarks listed in Schedule A (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as well as all proceeds and claims based on past, present, or future infringement.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates, cancels and discharges any and all of its interest in the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens.


The Administrative Agent hereby authorizes and requests that the Commissioner of Trademarks note and record the existence of this Termination and Release of Security Interest in Trademarks.
