TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “Release”) is made as of November 16, 2015, by Healthcare Financial Solutions, LLC, as successor by assignment to General Electric Capital Corporation, in its capacity as Administrative Agent (“Secured Party”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, AxelaCare Health Solutions, LLC, a Delaware limited liability company (“Grantor”) and Secured Party are parties to that certain Grant of a Security Interest – Trademarks, dated as of April 12, 2013 (the “Security Agreement”) pursuant to which Grantor granted security interest to Secured Party in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Party, including the Trademarks set forth on Schedule I hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on April 12, 2013, at Reel 5005, Frame 0882;

WHEREAS, Grantor has requested that Secured Party, and the Secured Party now desires to, terminate and release its Lien on and security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby automatically and unconditionally releases and terminates its Lien on and security interest in all of Grantor’s right, title and interest in and to the following (collectively the “Trademark Collateral”):

- (i) all of its Trademarks, including, without limitation, those referred to on Schedule I hereto;
- (ii) the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof; and
- (iii) all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof.

2. Secured Party hereby terminates the Security Agreement and fully and finally terminates, discharges, releases, cancels, reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party’s right, title and interest in and to the Trademarks and the Trademark Collateral.

4. The Secured Party hereby authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry.
