**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "**Release**") is dated as of October 2, 2014 by PACIFIC WESTERN BANK, a California state-chartered bank (as successor-by-merger to CapitalSource Bank), as administrative agent for itself and certain lenders ("**Administrative Agent**"), in favor of NOVETTA, INC. (formerly, White Oak Technologies, Inc.), a Maryland corporation, FGM, INC., a Virginia corporation, WHITE CLIFFS CONSULTING, LLC, a Maryland limited liability company, NOVETTA, LLC (formerly, DTA Acquisition, LLC), a Delaware limited liability company, NOVETTA SOLUTIONS, LLC (formerly, Data Technologies & Analytics, LLC), a Delaware limited liability company, and INTERNATIONAL BIOMETRIC GROUP, LLC, a New York limited liability company (collectively, the "**Grantors**").

**WHEREAS**, the Grantors and the Administrative Agent entered into that certain Third Amended and Restated Intellectual Property Security Agreement, dated as of September 19, 2012 (the "**Security Agreement**");

**WHEREAS**, with respect to the Patents, the Security Agreement was recorded with the United States Patent and Trademark Office on March 29, 2012 in Reel 027957, Frame 0036, and a corrective assignment was recorded with the United States Patent and Trademark Office on July 30, 2012 in Reel 028680, Frame 0674;

**WHEREAS**, with respect to the Trademarks, the Security Agreement was recorded with the United States Patent and Trademark Office on October 23, 2012 in Reel 4886, Frame 0684;

**WHEREAS**, with respect to the Copyrights, the Security Agreement was recorded with the United States Copyright Office on October 25, 2012 in Volume 3622, Document 119, Pages 1-16;

**WHEREAS**, pursuant to the terms and conditions of the Security Agreement, the Grantors granted to the Administrative Agent, on behalf of and for the ratable benefit of the Lenders, a security interest (the "**Security Interest**") in all of the Grantor's right, title and interest in, to and under the IP Collateral (as defined in the Security Agreement); and

**WHEREAS**, the Administrative Agent desires to terminate and release the Security Interest in the IP Collateral.

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

Capitalized terms used herein but not otherwise defined here shall have the meanings as given to such terms in the Security Agreement.

The Administrative Agent, on behalf of itself and the Lenders, hereby terminates, releases and forever discharges the Security Interest in the IP Collateral, and retransfers and reassigns to the Grantors, without representation or warranty of any kind, express or implied, free and clear of any claims by Administrative Agent, all right, title or interest of the Administrative Agent and the Lenders in, to or under the IP Collateral.
