## TRADEMARK ASSIGNMENT

WHEREAS, Assignor is a subsidiary of Assignee; and

WHEREAS, Assignor wishes to assign ownership of the Marks and all applications and registrations therefor, including the registrations identified on the attached Schedule A, to Assignee and Assignee wishes to acquire the Marks and all applications and registrations therefor, including the registrations identified on the attached Schedule A.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers, and conveys to Assignee all rights, title, and interest in and to the Marks, and any applications and registrations therefor, including the registrations identified on the attached Schedule A, together with the goodwill of the business associated with the use of and symbolized by the Marks, to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor if this Assignment had not been executed. Assignor further assigns, transfers, and conveys to Assignee the entire right, title, and interest in and to any and all causes of action and rights of recovery for past infringement of the Marks.
2. Assignor covenants and agrees to cooperate with Assignee so that Assignee may enjoy to the fullest extent the rights, title, and interest herein conveyed. Such cooperation shall include prompt execution of all papers prepared at the expense of Assignee which are deemed necessary or desirable by Assignee to perfect in it the rights, title, and interest conveyed in this Assignment.
3. Assignor warrants and represents that it has not entered into any assignments, contracts, or other understandings with third parties that would conflict with the rights granted in this Assignment.
4. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors, assigns, and legal representatives, and shall be binding upon Assignor, its successors, assigns, and other legal representatives.

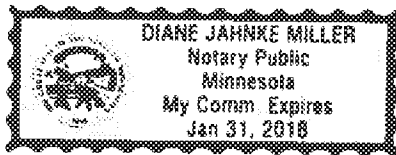

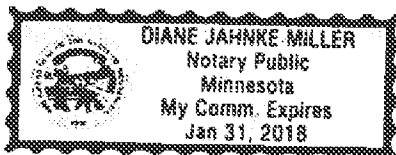
