TRADEMARK ASSIGNMENT

NOW THEREFORE, in exchange for mutual promises and other good and valuable consideration, receipt which is hereby acknowledged, ASSIGNOR does hereby assign, transfer and confirm unto ASSIGNEE all rights, title and interest in and to the said trademarks, including all rights under common law, together with that part of the goodwill of the business relating to said mark and which is symbolized by the said mark, as well as the right to recover damages and profits for past infringement therefor.

ASSIGNOR agrees to execute and deliver at the request of the ASSIGNEE, all papers, instruments, and to perform any other reasonable acts the ASSIGNEE may require in order to vest all ASSIGNOR's rights, title and interest in and to the said mark in the ASSIGNEE and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the ASSIGNEE, to the extent such evidence is in the possession or control of ASSIGNOR.
