Trademark Assignment

In the United States Patent and Trademark Office

WHEREAS, Cinram Group, Inc., a corporation organized under the laws of the State of Delaware, with offices at 2525 East Camelback Road, Suite 850, Phoenix, Arizona 85016 (the “Assignor”), owns certain trademarks and/or service marks which are associated with the Business, and applications and/or registrations for such marks which are associated with the Business, including as set forth on Exhibit A attached hereto and incorporated herein by this reference (the “Marks”);

WHEREAS, CT Acquisition Holdco, LLC, a limited liability company organized under the laws of the State of Delaware, with offices at 2525 East Camelback Road, Suite 850, Phoenix, Arizona 85016 (the “Assignee”), desires to acquire all of the right, title and interest of the Assignor in, to and under the Marks, together with the goodwill of the business symbolized by the Marks; and

WHEREAS, the Assignor and the Assignee have entered into that certain Contribution and Assignment and Assumption Agreement, dated November 10, 2015, pursuant to which the Assignor has agreed to transfer to the Assignee, among other things, all right, title and interest in and to the Marks.

All capitalized terms used but not defined in this Trademark Assignment shall have the meaning as set forth in the Contribution and Assignment and Assumption Agreement.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration paid by the Assignee to the Assignor, the receipt and sufficiency of which is hereby acknowledged, the Assignor does hereby sell, assign, transfer and convey unto the Assignee its entire right, title and interest in and to the Marks, and to the applications and/or registrations for the Marks and any renewals and extensions thereof (and the right to apply for the foregoing in any country), together with the goodwill of the business symbolized by the Marks and the business of the Assignor to which the Marks pertain, including the right to sue and recover for any past, present, or future infringement or any other unauthorized use thereof.

The Assignor authorizes and requests that the United States Commissioner of Patents and Trademarks and any other similar government authority to record the Assignee as owner of the Marks and issue any and all trademarks issued thereon to the Assignee, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of the Assignee and its successors, assigns or other legal representatives. The Assignee shall have the right to record this Trademark Assignment with all applicable government authorities and registrars so as to perfect its ownership of the Marks.


