INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (the "Agreement") is made and entered into this ____ day of October, 2015, by and between Samantha Skolnik, an individual having a primary address of 44 Taxiway Lindy Loop, Port Orange, Florida 32128 ("Skolnik") and OOGAA Home LLC, a Florida limited liability company having a principal address of 44 Taxiway Lindy Loop, Port Orange, Florida 32128 ("OOGAA") (collectively, the "parties").

The parties hereby agree as follows:

Skolnik hereby assigns to OOGAA, or its designee, all right, title, and interest in and to any and all inventions, original works of authorship, which Skolnik solely or jointly conceived or developed or reduced to practice, developments, concepts, improvements, designs, drawings, ideas, trademarks, or trade secrets, whether or not patentable or registrable under patent, copyright or similar laws, related to the business of OOGAA, or caused to be conceived or developed or reduced to practice, with the use of OOGAA's equipment, supplies, facilities, assets, or information or which arose out of any research or other activity conducted under the direction of OOGAA, including but not limited to all trademarks bearing any variation of the OOGAA name or logo, and which has not been already assigned from Skolnik to OOGAA by previous conveyance; (collectively referred to as "Intellectual Property").

Therefore, for valuable consideration, the receipt of which is acknowledged, Skolnik assigns to OOGAA one hundred percent (100%) of her right, title and interest in the Intellectual Property. The right, title and interest conveyed in this Assignment is to be held and enjoyed by OOGAA and OOGAA's successors as fully and exclusively as it would have been held and enjoyed by Skolnik had this assignment not been made.

Skolnik further agrees to: (a) cooperate with OOGAA in the protection of any patent, trademark, copyright or other intellectual property rights conveyed herein; (b) execute, verify, acknowledge and deliver all such further papers, including patent, trademark and copyright applications and instruments of transfer; and (c) perform such other acts as OOGAA lawfully may request to obtain or maintain any patent, trademark or copyright rights and any and all applications and registrations for the Intellectual Property in any and all countries.

The validity, construction and enforceability of this Agreement shall be governed in all respects by the law of the State of Florida. This Agreement may not be amended except in writing signed by a duly authorized representative of the respective parties. This Agreement shall control in the event of a conflict with any other agreement between Skolnik and OOGAA with respect to the subject matter hereof. The failure of either party to enforce its rights under this Agreement at any time for any period shall not be construed as a waiver of such rights.

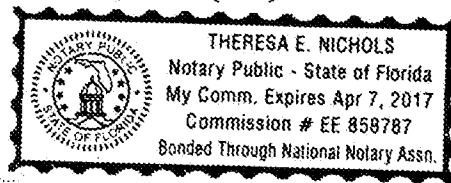

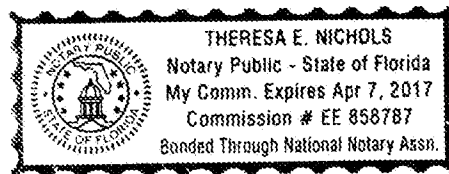
