TRADEMARK SECURITY AGREEMENT

WHEREAS, PEACH STATE LABS, LLC (the "Assignor") has entered into a Security Agreement, dated June 30, 2015 (the "Security Agreement"), in favor of Kayne Senior Credit II GP, LLC, in its capacity as Administrative Agent for certain lenders (the "Assignee");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby pledges and grants to the Assignee for the benefit of the lenders a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

The Assignor does hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

IN WITNESS WHEREOF, the Assignor has caused this Trademark Security Agreement to be duly executed by its officer thereunto duly authorized as of June 30, 2015.
