RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT (this "Release") is made as of November 7, 2015, by FIFTH THIRD BANK, as Lender (the "Lender") to SYSTEC CORPORATION, an Indiana corporation (the "Grantor"). Reference is hereby made to that certain Patent and Trademark Security Agreement between the Grantor and the Lender dated April 1, 2014, recorded in the United States Patent and Trademark Office ("USPTO") on April 9, 2014 at Reel 032637/ Frame 0001 and Reel 5256/ Frame 0537 (the "IP Security Agreement"). Terms used but not defined in this Release shall have the meanings given thereto in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, the Lender was granted a security interest in and to the intellectual property, including the Patents listed in Schedule A (the "Patent Collateral") and the Trademarks listed in Schedule B (the "Trademark Collateral");

WHEREAS, the Grantor has requested that the Lender terminate and release its security interests in and to the Patent Collateral and the Trademark Collateral and execute and deliver evidence of such termination and release for filing in the USPTO; and

WHEREAS, the Lender has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender hereby releases and terminates all security interests and other interests it may have in the Patent Collateral and the Trademark Collateral. The Grantor (or its designee) is hereby authorized to file this Release with the USPTO and any other governmental authority.


