STATEMENT RE RELEASE OF SECURITY INTEREST

1. Barrel O'Fun Snack Foods Co., now known as Barrel O'Fun Snack Foods Co., LLC, a Delaware limited liability company ("Owner"), granted a security interest in certain of its trademark registrations listed below (the "Trademarks") to American Credit Corporation pursuant to a Security Agreement dated on or about November 15, 1995 (the "Security Agreement"):

2. The Security Agreement was recorded at the U.S. Patent and Trademark Office ("PTO") on December 4, 1995, at Reel 1412, Frame 0768.
3. All debt of Owner to American Credit Corporation has been paid, satisfied, and discharged in full. Owner has no other, further, or continuing obligations owed to American Credit Corporation or which may be secured by the Security Agreement.
4. American Credit Corporation has not evidenced through a filing or recordation with the PTO, any release of its Security Agreement or any claimed interest in the Trademarks.
5. Owner has undertaken efforts to obtain a release from American Credit Corporation or other evidence to place on record that the Security Agreement is released and discharged. Based upon information and belief after diligent inquiry, American Credit Corporation is a closed institution and is no longer functioning. Attached as Exhibit A are research results from the National Information Center, a repository of financial data and institution characteristics collected by the Federal Reserve System, indicating that American Credit Corporation was acquired by Firstar Corporation, that Firstar Corporation was renamed to Firstar Holdings Corporation, and that Firstar Holdings Corporation closed as of January 1, 2000.
6. Owner is not able to obtain a release of the Security Agreement on the basis that American Credit Corporation, and its successor institution, are defunct. There are no assignments of the Security Agreement by American Credit Corporation of record, and Owner reasonably believes that there is no beneficial party of interest to the Security Agreement.
7. Based upon the information set forth in this Statement, Owner believes that any security interest or other right, title, or interest of American Credit Corporation in the Trademarks has ceased and terminated.
8. This Statement is being recorded with the PTO in the public interest in order to give third parties notification of matters relevant to the ownership and any claimed security interests in the Trademarks, and to clarify that the Security Agreement is of no further force or effect.

9. Undersigned, a duly-authorized representative of the Owner, makes this statement upon information and belief, and after due inquiry, and has actual knowledge that Section 3 of this Statement is true and accurate.

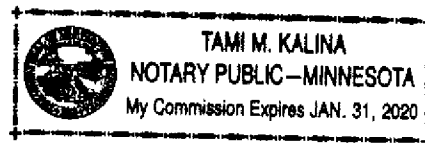
