**DECLARATION OF MANAGING MEMBER OF ATTRACT CHINA LLC,
CONCERNING OWNERSHIP OF TRADEMARKS**

I, Evan Saunders, declare and state as follows:

1. Attract China LLC, a Delaware limited liability company (“Attract China”), is the owner of: the marks A ATTRACT CHINA, 逍遥道, and XIAO YAO DAO; the United States Patent and Trademark Office Registrations for those marks; Registration Numbers 4367372, 4820537, 4820538; and all associated goodwill (together, the “Marks”). A list of the Marks, including associated registrations is set forth on Exhibit A.

2. I understand that the records of the United States Patent and Trademark Office (“PTO”) reflect that on or about November 6, 2015, an individual named Samuel M. Goodman (“Goodman”) submitted an assignment document for recordation with the PTO’s Assignment Recordation Branch; that the document purports to have been made by Goodman on behalf of Attract China; and that it purports to assign the Marks from Attract China to Goodman.

3. Goodman was not authorized to act on behalf of Attract China with respect to any purported transfer of ownership of the Marks, was not authorized by Attract China to assign the Marks to himself, and, consequently, is not the lawful owner of the Marks.

4. I understand that Goodman contends that he has certain rights with respect to the Marks arising out of a “General Security Agreement” and a “Trademark Security Agreement.” To the best of my knowledge and that of Attract China, Goodman has not conducted any secured party or similar sale with respect to the Marks, whether acting under those agreements or otherwise.

5. I understand that the above-referenced document submitted by Goodman is recorded at Trademark Reel: 005659, Frames: 0727-0745.

6. Accordingly, Attract China continues to be the legal and rightful owner of the Marks, including the registrations listed herein.

7. I am a manager of Attract China. As manager, I am authorized by Attract China to act for it and to provide this Declaration on its behalf. I have firsthand knowledge of the facts set forth in this declaration.
