This Assignment is deemed to have become effective as of November 23, 2015.

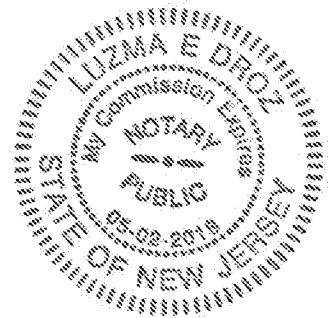
